Mayor Harman called the meeting to order and led the pledge to the flag.

FINANCE – Tracy made a motion to adopt Finance Ordinance #1555 in the amount of \$166,000.60, Tate second. VOTE-Yeas-Tracy, Tate, Fetzer, Karchner, Riffle, and Rizor. Nays-None. MOTION CARRIED 6-0.

Tracy made a motion to donate \$100.00 to the Fort Stepheson Bicentennial Celebration in Fremont, Ohio August 2-4, 2013, Rizor second. VOTE- Tracy, Rizor, Fetzer, Karchner, Riffle, and Tate. Nays – None. **MOTION CARRIED 6-0.** 

**PUBLIC SAFETY** – Tate reported Chief Whitehead has been off on medical leave and is not scheduled to return until January 2, 2013. Because he had vacation and floating holiday time already scheduled during this time, he would like to be compensated or carry the time into next year rather than lose the time. Fetzer made a motion to pay out Chief Whitehead's two (2) vacation days, and two (2) floating holiday days at his hourly rate of pay, Tate second. VOTE- Yeas-Fetzer, Tate, Karchner, Riffle, Rizor, and Tracy. Nays- None. **MOTION CARRIED 6-0.** 

Chief Whitehead asked permission to explore funding options, and possible donations, to purchase a canine unit for the department. Tate made a motion to allow Chief Whitehead to secure funding and donation pledges for a canine unit for the village Police Department, Karchner second.
