WOODVILLE VILLAGE COUNCIL - REGULAR MEETING

Minutes of the Regular Meeting of Woodville Village Council held on Monday, March 10, 2014 in Council Chambers, 530 Lime Street at 7:00pm. Present at Roll Call were Mayor Rich Harman, Fiscal Officer Barb Runion, Council Members — Denny Fetzer, Judy Karchner, Joe Riffle, Stephanie Rizor, Jeff Tate, and Ty Tracy. Also present: Village Administrator Keith Kruse, Solicitor Bob Kuhlman, and Karen Schepman. Chief Roy Whitehead was excused.

Mayor Rich Harman called the meeting to order and led the pledge to the flag.

CORRESPONDENCE- Mayor Harman shared the following correspondences:

- > Thank you note from the Glassford family for the planter sent for Eleanor's memorial service.
- ▶ Letter from the Sandusky County Health Department stating they will only accept signed public health nuisance complaints from this point forward. This change is due to the significant number of invalid anonymous complaints received.
- ▶ Letter from Rene Dix, on behalf of the Woodville Business & Community Association (WBCA) asking permission to hold a Farmer's Market in Trail Marker Park on the fourth Saturday, May September from 9:00am 1:00pm. They have secured insurance for the five dates from Wittcamp Ins. Fetzer made a motion to allow the WBCA use of Trail Marker Park on the fourth Saturday, May- September from 9:00am 1:00pm, Rizor second. VOTE- Yeas-Fetzer, Rizor, Karchner, Riffle, Tate, and Tracy. Nays None. MOTION CARRIED 6-0.

VILLAGE ADMINISTRATOR - Keith Kruse reported:

- Project Update:
 - > New School: The School will sign the Electric Service Agreement at their next Board meeting.
 - > Sewer Separation: The sewer was relined from the 100 block Main Street back to College Ave. The pumps are scheduled to be delivered for the Port Clinton Rd. Lift Station.
 - Solar Field: Changes in Solar Planet administration led to proposed changes to the contract. John Courtney has told Solar Planet the contract stays as is, or we are finished with it.
- Other:
 - Woodville Township Trustees have been approved to receive funding for another siren. The location for the new siren will be the sewer plant on Port Clinton Road.
 - Renewing the Woodmore soccer agreement for the 2014 season.
 - > Several water issues have been repaired: Riverside Dr., Erie St, Cherry St., and Main/Findlay Rd.
 - Receiving quotes to install security cameras on several public buildings throughout the village. Especially for the brush dump and impound lot.
