Minutes of the Regular Meeting of Woodville Village Council held on Monday, July 13, 2015 in Council Chambers, 530 Lime Street at 7:00pm. Present at Roll Call were Mayor Rich Harman, Fiscal Officer Barb Runion, Council Members-Denny Fetzer, Judy Karchner, Joe Riffle, Stephanie Rizor, Jeff Tate, and Ty Tracy. Mayor Rich Harman called the meeting to order and led the pledge to the flag.

<u>AUDIENCE PARTICIPATION-</u> Mr. Linke requested something be done regarding the water that is backing up from the ditch onto his property on the corner of W. Main St. and Co. Rd. 28. ADMINISTRATIVE & PERSONNEL- Riffle - No report.

PUBLIC WORKS & MAINTENANCE – Karchner reported during the storm in late June a substantial amount of water backed-up on the W. Main St/Pemberville Rd. area. Karchner's son, who works for a developer, assessed the issue and determined that the new Woodmore School retention pond was not adequate to handle the extreme rainfall.

ENVIRONMENTAL & COMMUNITY DEVELOPMENT – Rizor reported that Rene Dix and Lynn Bunn of the 4th of July Celebration Committee expressed their appreciation to all village personnel for their extra effort in making the Celebration happen this year despite the flooding in Trail Marker Park.

RECREATION & PARKS DEVELOPMENT – Fetzer reported Pool Manager Dawn Peters has accepted a full time position at a water park in Sandusky, Ohio. Peters will continue working at the Woodville Pool evenings and for special events.

Fetzer requested Jim Taylor, Ryan Paul, and Hunter Gregory be recognized for their quick action in saving two young men from the flooded Portage River in late June. Runion will prepare certificates for the three gentlemen and invite them to the next council meeting to be recognized.
