WOODVILLE VILLAGE COUNCIL - REGULAR MEETING

Minutes of the Regular Meeting of Woodville Village Council held on Monday, August 10, 2015 in Council Chambers, 530 Lime Street at 7:00pm. Present at Roll Call were Mayor Rich Harman, Fiscal Officer Barb Runion, Council Members-Denny Fetzer, Judy Karchner, Stephanie Rizor, Jeff Tate, and Ty Tracy. Also present: Village Administrator Keith Kruse, Solicitor Bob Kuhlman, Police Chief Roy Whitehead, Karen Schepman, Pat Dunn, and Evan Matheney. Council Member Joe Riffle was excused.

Mayor Rich Harman called the meeting to order and led the pledge to the flag.

Minutes of Regular Council and Finance Committee meetings on July 27, 2015 were approved as presented.

Again Ohio (DAO). Mr. Matheney detailed the DAO program which provides training for various practical life skills and positive modeling to at-risk youth aging out of the foster care system. There will be two new subsidized housing sites in our area soon. The Solomon Lutheran Parsonage in Woodville will be home to four young women, and the Bethel United Brethren Parsonage in Elmore will host three young men. Both Parsonages will have one site manager. Mr. Matheney exited the meeting at 7:24pm.

<u>CORRESPONDENCE-</u> Mayor Harman read a notice from Securance Service Insurance, Inc. announcing that they have joined Sprouse Insurance. Office and staff in the Gibsonburg branch will remain unchanged.

<u>OLD BUSINESS</u>- Mayor Harman requested the status for the street repairs throughout the village. Kruse replied all areas have been measured for materials. Unexpected tasks have delayed the street repair projects, and Kruse is hopeful the projects will be completed within the next couple of weeks.

The Village is participating in the class action suit against Morton and Cargill salt companies concerning the high prices charged for salt in 2013 and 2014 winter seasons.
