## WOODVILLE VILLAGE COUNCIL - REGULAR MEETING

Minutes of the Regular Meeting of Woodville Village Council held on Monday, October 12, 2015 in Council Chambers, 530 Lime Street at 7:00pm. Present at Roll Call were Mayor Rich Harman, Fiscal Officer Barb Runion, Council Members-Denny Fetzer, Judy Karchner, Joe Riffle, Stephanie Rizor, Jeff Tate, and Ty Tracy. Also present: Village Administrator Keith Kruse, Solicitor Bob Kuhlman, Karen Schepman, Deb Wallace of the Suburban Press, Denise Maye, Robin Richter, and Pat Dunn.

Police Chief Roy Whitehead was excused.

Mayor Rich Harman called the meeting to order and led the pledge to the flag.

Minutes of Regular Council and Finance Committee meetings on September 28, 2015 were approved as presented.

AUDIENCE PARTICIPATION- Robin Richter, Sandusky County Senior Programs Director, and Denise Maye, Woodville Senior Center Site Supervisor presented information regarding the upcoming Senior Levy which will be on the November 3, 2015 ballot. The levy will be a .5 mill replacement with a .5 mill increase. If the levy passes it will restore health assessment clinics, allow more educational and social opportunities, and support a passenger van for grocery shopping and other activities.

Mayor Harman presented Ms. Richter, and Ms. Maye with a proclamation in support of the Senior Levy from the entire village council.

Richter and Maye exited the meeting at 7:15pm.
