# **WOODVILLE VILLAGE COUNCIL - REGULAR MEETING**

Minutes of the Regular Meeting of Woodville Village Council held on Monday, September 12, 2016 in Council Chambers, 530 Lime Street at 7:00pm. Present at Roll Call were Mayor Rich Harman, Fiscal Officer Barb Runion, Council Members-Patrick Dunn, Judy Karchner, Joe Riffle, Stephanie Rizor, Jeff Tate, and Ty Tracy. Also present: Village Administrator Keith Kruse, Solicitor Bob Kuhlman, Deb Wallace of The Suburban Press, Karen Schepman, Mike O'Connor, and Sgt. Tom Gearheart.

Chris Hilton entered the meeting at 7:08pm.

Police Chief Roy Whitehead entered the meeting and Sgt. Tom Gearheart exited at 7:16pm.

Mayor Rich Harman called the meeting to order and led the pledge to the flag.

Minutes of the Regular Council and Finance Committee meetings held on August 22, 2016 were approved as presented.

<u>AUDIENCE PARTICIPATION</u> — Mr. O'Connor, President of the Woodville Historical Society requested permission to install a new window in the back of the museum. The Historical Society will purchase the window (\$2,926.00). O'Connor also asked if village employees could help remove the steel bars covering the window prior to the installation. Kruse will schedule the employees to remove them. Tracy made a motion to allow the new window for the museum building. Tate second. VOTE – Yeas – Tracy, Tate, Dunn, Karchner, Riffle, and Rizor. Nays – None. <u>MOTION CARRIED 6-0.</u> Council thanked Mr. O'Connor for the Historical Society's continued support for the maintenance of the museum building.

Kruse reported Nick Avers recently purchased the duplex at 400 W. First Street and has been doing major renovations to the property. Mr. Avers would like to add a driveway to the rear of the duplex to allow both tenants off street parking, and therefore is requesting a curb cut on N. Elm Street. Karchner made a motion to allow the curb cut on N. Elm Street, Rizor second. VOTE – Yeas – Karchner, Rizor, Dunn, Riffle, Tate, and Tracy. Nays – None. **MOTION CARRIED 6-0.**

OLD BUSINESS- Mayor Harman reported that the travel arrangements are complete for the forum on law enforcement and canine encounters to be held in Washington DC on September 21, 2016. This forum is an opportunity for law enforcement executives and officers, community leaders, and subject matter experts to discuss best practices and effective communication strategies for law enforcement agencies in the aftermath of a canine encounter. The Office of Community Oriented Policing Services (COPS) will pay for travel and lodging expenses for Mayor Harman and Chief Whitehead. Tate made a motion to allow Chief Whitehead to attend the forum in Washington DC on September 20, 21, and 22, Karchner second. VOTE – Yeas – Tate, Karchner, Dunn, Riffle, Rizor, and Tracy. ### VILLAGE ADMINISTRATOR - Keith Kruse reported:

- > WATER PLANT: Working with Poggemeyer Design Group (PDG) to submit the Water Treatment Plant (WTP) Improvements Project for funding through the Ohio Water Supply Revolving Loan Account (WSRLA). We received the Source Water Protection Plan (SWPP) certificate.
  - Kruse requested a Public Works & Maintenance committee meeting to discuss improvements for the WTP.
- > SEWER SEPARATION PROJECT: Continuing the sampling for CSO closures, and completing the non-compliance residential list for sewer separations.
- > SEWER PLANT: No report.
- > ELECTRIC DEPT: Amplex will be surveying our electric lines route in order to draft a plan to provide fiber optics throughout the village.
- ➤ OTHER: Kruse will attend the AMP conference from September 26 29 in Columbus, Ohio. Kruse will attend the ODOT's Rural Consultation meeting on September 13 in Bowling Green, Ohio. Chief Whitehead introduced Chris Hilton, a candidate for Sandusky County Sheriff. Mr. Hilton gave a brief description of his credentials, pledged to bridge the communication gap throughout the entire county, and to work diligently, with all law enforcement agencies, on the heroin/opiate epidemic affecting our county.

<u>MAYOR'S REPORT</u>- Mayor Harman reported that Gibsonburg Officials did an outstanding job in organizing the Public Safety Memorial Event on Sunday, September 11, 2016.

Mayor Harman talked with State Representative, Bill Reineke after the event regarding the ongoing issues with the horrible condition of St. Rt. 20. The letter sent in June to Mr. Reineke has been sent again for further review.
