WOODVILLE VILLAGE COUNCIL - REGULAR MEETING

Minutes of the Regular Meeting of Woodville Village Council held on Monday, November 28, 2016 in Council Chambers, 530 Lime Street at 7:00pm. Present at Roll Call were Mayor Rich Harman, Fiscal Officer Barb Runion Council Members-Patrick Dunn, Judy Karchner, Joe Riffle, Stephanie Rizor, and Ty Tracy. Also present: Solicitor Bob Kuhlman and Karen Schepman.

Council Member Jeff Tate entered the meeting at 7:10pm.

Village Administrator Keith Kruse and Police Chief Roy Whitehead were excused.

Mayor Rich Harman called the meeting to order and led the pledge to the flag.

Minutes of the Regular Council meeting held on November 14, 2016 were approved as presented.

AUDIENCE PARTICIPATION - None.

CORRESPONDENCE- None.

<u>OLD BUSINESS</u>- Council members had an extensive discussion regarding the ongoing issues with U.S. Rt. 20 at the Lime Street intersection. Council Member Pat Dunn will contact the City of Swanton regarding their relations with ODOT concerning the section of U.S. Rt 20 that is within their corporation limits. Runion will compile the requirements needed in order to raise the \$5.00 vehicle registration permissive tax fees to aid in maintaining all village streets. On behalf of the village, Kuhlman will draft a letter to ODOT asking them to honor our request that the damaged lane be closed immediately to ensure the safety of those traveling through the village.

REPORTS:

ADMINISTRATIVE & PERSONNEL- Riffle reported Kruse has recommended the employment of Jason Hindall as a Lineman 1 in our electric department. Mr. Hindall comes with experience in primary/secondary voltage and substation maintenance/repairs. Riffle made a motion to hire Jason Hindall on December 5, 2016, at a wage of \$20.00 per hour, a 90 day probationary period, accrue two (2) weeks' vacation beginning January 1, 2017 until December 31, 2021, beginning January 1, 2022 he will accrue three (3) weeks' vacation until he reaches the next accrual as stated in the policy and personnel manual. Dunn second. VOTE – Yeas – Riffle, Dunn, Karchner, Rizor, Tate, and Tracy. Nays – None. MOTION CARRIED 6-0.

Tracy reported the 2017 health insurance premium renewal increased by 10.49% and the current monthly rate will be \$10,328.47. Runion was able to lower the premiums 4% by changing the Rx Plan from A to B. Tracy made a motion to renew the 2017 Medical Mutual Employee Health Insurance Plan, Tate second. VOTE-Yeas- Tracy, Rizor, Dunn, Karchner, Riffle, and Tate. Nays- None MOTION CARRIED 6-0.
