MINUTES – June 12, 2017

WOODVILLE VILLAGE COUNCIL - REGULAR MEETING

Minutes of the Regular Meeting of Woodville Village Council held on Monday, June 12, 2017 in Council Chambers, 530 Lime Street at 7:00pm. Present at Roll Call were Mayor Rich Harman, Fiscal Officer Barb Runion Council Members-Patrick Dunn, Judy Karchner, Joe Riffle, Stephanie Rizor, and Ty Tracy. Also present: Village Administrator Keith Kruse, Police Chief Roy Whitehead, Karen Schepman, Paul Runion, Lisa Grant, and Ethan Thornbury. Council Member Jeff Tate and Solicitor Bob Kuhlman were excused.

Mayor Rich Harman called the meeting to order and led the pledge to the flag.

Minutes of the Finance Committee and Regular Council meetings held on May 22, 2017 were approved as presented.

AUDIENCE PARTICIPATION -

- Mayor Harman welcomed Boy Scout Ethan Thornbury to the meeting. Ethan is working on his Citizenship in the Community merit badge, and will observe the meeting.
- Mr. Runion stated his opinion, frustrations, and disappointment regarding the Ohio Ethics Commission nepotism regulations.

<u>CORRESPONDENCE</u>- The City of Bellevue will be hosting the Vietnam Veterans Memorial Wall from June 22 -25, 2017, and extended an invitation to join them in honoring and remembering those that served during the Vietnam War.

<u>OLD BUSINESS</u>- Mayor Harman questioned the procedure, or timeframe, residents are allowed to clean up the mounded dirt area created when they are completing their sewer separations. Many of these mounded areas have tall grass and weeds growing on top of them and are becoming an eyesore. Kruse replied that residents must still control the grass/weeds, and some have been notified by letter to do so.
