Minutes of the Regular Meeting of Woodville Village Council held on Monday, September 11, 2017 in Council Chambers, 530 Lime Street at 7:00pm. Present at Roll Call were Mayor Rich Harman, Fiscal Officer Barb Runion, Council Members-Patrick Dunn, Judy Karchner, Joe Riffle, Stephanie Rizor, Jeff Tate, and Ty Tracy. <u>OLD BUSINESS</u>- Tracy reported Kruse and Kuhlman discussed how to move forward with the Zoning Board of Appeals decision and vote during their August 17, 2017 meeting regarding a variance for Anita Greiger. Since it has already been determined that the board was convened in error, Kuhlman recommended council vote to confirm the Zoning Board had no authority to vote on the issue.

VILLAGE ADMINISTRATOR - Keith Kruse reported:

- ➤ WATER DEPT: Changed out the generator from overhead to a pad mount and completed a 6 hour test run to operate the plant on the generator.
- SEWER SEPARATION PROJECT: Poggemeyer Design Group (PDG) is working on the permit modification needed in order to meet deadlines to close the Combined Sewer Overflows (CSO). The village is set to replace another group of sidewalks for those properties that are now separated.
- > SEWER DEPT: Conducting interviews for a Wastewater Plant Operator.
- ELECTRIC DEPT: Working with Amplex on Fiber optic options and making ready the poles. The Buckeye Cable pole agreement has been sent to John Courtney for final review.
- OTHER: Water meter verification to begin this month.
