Zoning or Conditional Use

No person, firm or corporation shall locate, erect, construct, reconstruct, enlarge or structurally alter any building, accessory building, utility building or structure within the Village or change the use of the building or land without having first obtained a zoning permit.

If the zoning permit is issued for the purpose of constructing a new building, or structure and such construction is not begun within a six-month period, then the zoning permit shall be null and void. The permit may be valid for six months after the date of issuance or until completion of the project within one year after such date. The Village does not enforce private restrictive covenants (deed restrictions). They are private matters and do not supersede or supplement any of these regulations.

This Permit conveys no right to occupy any street, alley or sidewalk, or any part thereof, either temporary or permanently.

This permit may be valid for six months after the date of issuance or until completion of the project within one year after such date.

This permit is granted on the express condition that the said construction shall in all respects conform to the Ordinances of the Village of Woodville, and all Laws of the State of Ohio, regulation the construction of buildings. This permit may be revoked at any time upon the violation of any provision of said laws.

Conditions of Approved Permit (check all that apply)

- ☐ Property owner is responsible for location of property lines.
- ☐ Fence - maintenance is the responsibility of the property owner.
- ☐ Fence - must allow access to Village to read meters, electric & water where applicable. If locked, must provide Village with key or code.
- ☐ Fence/Shed - location to be at the discretion of the Zoning Inspector, the Village may remove to access utilities if necessary, at owner's expense.
- ☐ Shed/Accessory Building - must be a minimum of 3 feet on side lot line and 6 feet on rear lot line. Must be 10' off of rear property line if utilities are present, excluding exterior side lot (corner lot).
- ☐ Pool - must be located 8 feet from property line and have a removable or locking ladder.


