REPEALING ORDINANCE #9-2009 AND SETTING NEW PAY RANGES FOR VILLAGE EMPLOYEES

WHEREAS, the Council of the Village of Woodville wishes to establish a new range of salaries and hourly rates for Village employees; and

WHEREAS, certain established positions have been added/deleted and need to be restructured, and

WHEREAS, a policy manual has been adopted to which this ordinance will conform;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Woodville, Sandusky County, Ohio that the pay scale for employees and departments shall be as follows:
