- 3. It is found and determined that all formal actions of the Council of the Village of Woodville, Ohio concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council, that all deliberations of this Council that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- 4. This Ordinance is declared to be an emergency measure for the health, safety, and welfare of the public.
