

**ORDINANCE #18-2012**

**AN ORDINANCE REPEALING ORDINANCE #11-2012**

WHEREAS, the Council of the Village of Woodville, Sandusky County, Ohio passed on August 27, 2012 the following;

**AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO  
CONTRACT WITH ADVANTAGE FORD FOR THE PURPOSE OF PURCHASING A  
2012 FORD F550 CAB & CHASSIS TRUCK FOR THE VILLAGE OF WOODVILLE**

WHEREAS, the Village of Woodville, Sandusky County, Ohio desires to purchase a 2012 Ford F550 Cab & Chassis Truck for the Village of Woodville, and

WHEREAS, Advantage Ford has submitted the lowest and best bid after considering the condition of said truck and the optional equipment, and

WHEREAS, the Village of Woodville, Sandusky County, Ohio desires to accept Advantage Ford's bid;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Woodville, Sandusky County, Ohio that:

Section 1: Keith Kruse, as Village Administrator, of the Village of Woodville, Sandusky County, Ohio is hereby authorized and directed for and in the name of the Village of Woodville, Ohio and on its behalf to execute a contract with ADVANTAGE FORD to provide the 2012 Ford F550 Cab & Chassis Truck for \$39,853.84 for the Village of Woodville, said contract to be in substantially the same form now on file with the Fiscal Officer of the Village of Woodville, Sandusky County, Ohio.

Section 2: It is found and determined that all formal actions of the Council of the Village of Woodville, Sandusky County, Ohio, concerning and relating to the adoption of this ordinance were taken in an open meeting of this Council and all deliberations of this Council that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

WHEREAS, Advantage Ford cannot deliver the aforementioned vehicle for the reason that the "Trans PTO Prov" was not installed during the manufacturing process, and

WHEREAS, the Village of Woodville desires to secure the purchase of 2013 Ford F550 Cab & Chassis Truck;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Woodville, Sandusky County, Ohio that:


Section 1: Ordinance #11-2012 is repealed in its entirety.

Section 2: Keith Kruse, as Village Administrator, of the Village of Woodville, Sandusky County, Ohio is hereby authorized and directed for and in the name of the Village of Woodville, Ohio and on its behalf to execute a contract with ADVANTAGE FORD to provide the 2013 Ford F550 Cab & Chassis Truck for \$40,088.84 for the Village of Woodville, said contract to be in substantially the same form now on file with the Fiscal Officer of the Village of Woodville, Sandusky County, Ohio.

Section 3: It is found and determined that all formal actions of the Council of the Village of Woodville, Sandusky County, Ohio, concerning and relating to the adoption of this ordinance were taken in an open meeting of this Council and all deliberations of this Council that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
