## **RESOLUTION #10-2013**

## A RESOLUTION TO ACCEPT THE EXPEDITED TYPE II ANNEXATION OF TERRITORY BY PETITION OF THE OWNER JOODMORE LOCAL SCHOOL DISTRICT, PETITIONER WITH AARON M. GLASGOW, ESQ. AS AGENT FOR THE PETITIONER AS REQUIRED BY OHIO REVISED CODE 709.02

WHEREAS, Woodmore Local School District, Petitioner with Aaron M. Glasgow, Esq. as Agent for the Petitioner has filed a Petition with the County Commissioners of Sandusky County, Ohio to annex certain land to the Village of Woodville, and

WHEREAS, the land sought to be annexed totals 12.97 acres, more or less, in size and is described in the Petition to Annex, and

WHEREAS, the County Commissioners of Sandusky County on the 5<sup>th</sup> day of March, 2013 ordered that the prayer of the Petition to Annex be granted and that the territory described in the Petition may be annexed to the Village of Woodville all according to County Commissioner' Resolution No. 2013-88, and

WHEREAS, the transcript of the proceedings was filed with and received by the Fiscal Officer of the Village of Woodville on the 12<sup>th</sup> day of March, 2013, and

WHEREAS, Ohio Revised Code 709.04 requires that at the next regular session of the legislative authority of the municipal corporation to which annexation is proposed, after the expiration of 60 days from the date of delivery required by Ohio Revised Code 709.03C(1), the Fiscal Officer shall lay the transcript and the accompanying map or plat and the petition before the legislative authority of the Village of Woodville, and

IEREAS, Ohio Revised Code 709.04 requires that thereupon the legislative authority, by resolution or ordinance, shall accept or reject the application for annexation, and

WHEREAS, the Fiscal Officer has now laid before the Council of the Village of Woodville the above named documents, and Council has considered all of these documents, and has determined that it is in the public interest to accept the application for annexation.

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Woodville, Sandusky County, Ohio, that:

SECTION 1. The application for annexation of the property described in the aforesaid Petition to Annex is hereby accepted in accordance with Ohio Revised Code 709.04

SECTION 2. The Fiscal Officer shall make three copies of the following documents:

- A. Petition filed by Woodmore Local School District, Petitioner with Aaron M. Glasgow, Esq. as Agent for the Petitioner.
- B. The map accompanying the Petition.
- C. A transcript of the proceedings of the Board of County Commissioners
- D. Resolution #4-2013 passed by the Village of Woodville on February 25, 2013.
- E. Resolution #5-2013 passed by the Village of Woodville on February 25, 2013.
- F. This Resolution accepting the annexation

With a certificate to each copy that it is correct.

TION 3. The Fiscal Officer of the Village of Woodville shall then deliver a true copy of the documents listed in Section 2 to the County Auditor, to the County Recorder, and to the Secretary of State of Ohio upon the effective date of this resolution, and shall then forthwith, notify the Sandusky County Board of Elections of the change in the Village of Woodville, Sandusky County, Ohio boundaries.

SECTION 4. It is hereby found and determined that all formal actions by this Council or any of its committees relative to the passage of this resolution were taken in meetings open to the public in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code.
