

## RESOLUTION #4-2013

### A RESOLUTION IN COMPLIANCE WITH OHIO REVISED CODE 709.023(C) RELATING TO THE EXPEDITED TYPE II ANNEXATION OF TERRITORY BY PETITION OF THE OWNER WOODMORE LOCAL SCHOOL DISTRICT

WHEREAS, on the 7<sup>th</sup> day of February, 2013 a Petition for Expedited Type II Annexation of certain territory in Woodville Township, Sandusky County, Ohio was filed in the Office of the Sandusky County Commissioners by Woodmore Local School District, Petitioner with Aaron M. Glasgow, Esq. as Agent for the Petitioner, and

WHEREAS, under the provisions of Ohio Revised Code 709.023(C) the legislative authority of the Village of Woodville shall, by ordinance or resolution, adopt a statement indicating what services, if any, the municipal corporation will provide to the territory proposed for annexation upon annexation.

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Woodville, Sandusky County, Ohio, that:

SECTION 1. In accordance with Ohio Revised Code 709.023(C) Council declares that it will provide the following services to the territory proposed for annexation immediately upon annexation:

- a. Water service, sewer service, and electrical service will all be provided by the Village of Woodville
- b. Police services will be provided by the Village of Woodville.
- c. Planning and zoning will be provided and administered by the Village of Woodville.


SECTION 2. Should the territory (a) be annexed and (b) subsequently become subject to zoning pursuant to the Woodville Village Code, and (c) the municipal zoning permits uses in the annexed territory that the Woodville Village Council determines are clearly incompatible with the uses permitted under current county or township zoning in the adjacent land remaining in the township from which the territory was annexed, the Woodville Village Council will require, in the zoning ordinance permitting the incompatible uses, the owner of the annexed territory to provide a buffer separating the use of the annexed territory and the adjacent land remaining within the township should land adjacent to the territory be determined to be unincorporated territory.

SECTION 3. A true copy of this resolution shall be certified by the Fiscal Officer and forwarded to the Board of the County Commissioners of Sandusky County, Ohio and to the Petitioner through its agent.

SECTION 4. It is hereby found and determined that all formal actions by this Council or any of its committees relative to the passage of this resolution were taken in meetings open to the public in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code.


