ORDINANCE #6 - 2015

AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF WOODVILLE, OHIO AND DECLARING AN EMERGENCY.

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the codified ordinances of Woodville, Ohio;

WHEREAS, numerous sections in the traffic, general offenses and fire prevention codes need to be updated so as to conform to enactments of the Ohio General Assembly;

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF WOODVILLE OHIO:

SECTION 1: That the ordinances of Woodville, Ohio of a general and permanent nature as revised, recodified, rearranged and consolidated into component codes, titles, chapters and sections within the 2015 Replacement Pages to the Codified Ordinances are hereby approved and adopted.

SECTION 5: That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, welfare and safety and for the further reason that there exists an imperative necessity for the earliest publication and distribution of the Codified Ordinances to the officials and residents of the Village, so as to facilitate administration, daily operation and avoid practical legal entanglements.
